Care and cleaning

Regular cleaning is easy, quick and helps keep Sunbrella® Supreme looking new.

- Rinse with clean water.
- Clean with mild soap and lukewarm water.
- Rinse again to remove soap.
- Allow to air dry.

For tougher stains

- Mix 1/2 cup of chlorine bleach and 1/4 cup of mild soap in 1 gallon of lukewarm water.
- Spot clean the stain with the mixture and a soft sponge or cloth.
- If possible, avoid prolonged application of bleach to sewing threads.
- Thoroughly rinse bleach mixture with clean water.
- Allow to air dry.

Strong solvents, such as acetone or paint thinner should not be used on Sunbrella® Supreme fabric.

Limited warranty

The limited warranty coverage period is five years from the date of original installation.

This limited warranty covers Sunbrella® Supreme fabric only. This limited warranty is valid with proof of purchase from the original purchaser. This limited warranty does not cover normal fabric care and cleaning; damage from misuse, abuse, or improper installation; or costs associated with replacement of the fabric, including labor and installation. Glen Raven's liability is expressly limited to this warranty. Glen Raven reserves the right to inspect the fabric submitted for claim.

Glen Raven will supply new equivalent fabric to replace the fabric that becomes unserviceable during the warranty period. Replacement fabric is warranted under the remaining term of the original warranty.
